


## **Digital Training**

- Learners can monitor their own progress through the book relative to class average. Statistics for Coverage and Time Spent is available for the entire training.





#### Stormplayer Case

In 2015, Stormplayer successfully went public, after which the share price of Stormplayer soared to RMB 123, the market value of Stormplayer rose to RMB 36.9 billion and Feng Xin's worth broke ten billion. However, in September 2019, Feng Xin, the company's actual controller, was arrested upon approval by the procuratorate for being suspected of offering bribes to non-state functionaries. The number of Stormplayer' employees is from more than 1300 in 2016 to only 10 left.

#### Dajiang UAV

In 2018, Dajiang found that the company's internal R&D, procurement, quality control, sales, administration, and finally to the post-sale one-stop corruption network. In the two-month check, Dajiang disposed 45 persons suspected of corruption and dereliction of duty; 16 persons were handed over Police due to serious problems, and another 29 persons were directly dismissed. Dajiang has discovered that corruption is far more widespread than thought, and is expected to affect more than a hundred people. The corruption is conservatively estimated to have cost more than RMB 1 billion, more than twice the amount of all year-end benefits in 2017.

#### 暴风音影案

2015年,暴风影音成功上市,上市后的暴风影音股价飞涨至123元, 暴风影音市值涨到369亿元,冯鑫的身价也被百亿。但在2019年9月公司实控人冯鑫因涉嫌对非国家工作人员行贿罪、职务侵占罪被检察院批准逮捕。而公司从2016年的1300余名员工到目前仅仅剩余10名员工。

#### 大疆无人机

2018年中,大疆发现公司内部从研发、采购、品控、销售、行政。最后 到售后一条龙的贪腐网络。在两个月的清查中,大疆共处理涉嫌腐败 和渎职人员45人,问题严重、移交公安机关的有16人,另外还有29人 被直接开除。大疆发现腐败的范围比想象的要大很多,预计牵涉到的 范围超过百人。这一轮腐败行为保守估计损失金额超过10亿元人民 币,这一数字为2017年所有年终福利的2倍以上。








